

# MAGIC UPLIGHTING, INC.

## Rental Contract

This agreement made and entered into this day by and between Magic UpLighting, Inc. and

there after called Client, is as follows:

That upon the terms and conditions herein expressed and in consideration of the covenants and agreements herein expressed, Magic UpLighting, Inc. does hereby grant unto Client the right to use the following described equipment: SEE ATTACHED RENTAL FORM. This agreement allows use of equipment by Client for said purpose of \_\_\_\_\_ on dates and times as indicated below.

Client agrees with Magic UpLighting, Inc. that if damage was to happen towards equipment noted on the Rental Form the sum of the damage equipment should be payable as set forth in agreement. Client acknowledges receipt of a copy of the regulations governing the use of Magic UpLighting, Inc. equipment and agrees to be bound by the terms thereof. If a security deposit is required before the event Magic UpLighting, Inc. will return all or a portion of this security deposit to the Client promptly after verifying equipment is undamaged. Magic UpLighting, Inc. has reasonable opportunity to inspect the equipment provided and deducted any sum for repair or replacement. **If no damage deposit is required,** Client agrees that Magic UpLighting, Inc. may charge the customer if there was damage or missing equipment. Magic UpLighting, Inc. will supply Client with invoice before charging any additional fees due to damage or missing equipment.

Client hereby covenants and agrees to pay a sum of **\$150 non-refundable deposit**, which goes towards the services Magic Uplighting, Inc. will be providing for event. Client can choose to add any additional services prior to event as long as Magic Uplighting, Inc. is notified within two weeks and the equipment is available. Client can also cancel any individual rental service without any charge as long as packages or full service is not cancelled. If full service is cancelled the deposit of \$150 will not be refunded due to loss of potential booking. Equipment will be reserved upon receipt of a signed Contract, and the required deposit. 50% of total rental fees should be paid 1 month prior for the use of the equipment. **The final 50% of rental fees must be paid no later than two weeks before the event.** The Client will be required to pay a \$30.00 fee on all returned checks. Magic UpLighting, Inc. does not accept checks within less than 21 days of the contracted event date.

Client shall have possession of the equipment for the purpose and term aforesaid. Client hereby waives and releases any claim for damages against Magic UpLighting, Inc., its employees and third-party contractors hired by Magic UpLighting, Inc. on account thereof. All equipment must be used according to rules set forth in contract. **IF CLIENT AGREES WITH ALL TERMS OF THIS CONTRACT, THE CLIENT WILL NEED TO SIGN THE CONTRACT.**
